



# **eINSURED Protect ONLINE Promotion**

Last update: 24 March 2025

#### **PROMOTION PERIOD**

The Bank of China (Malaysia) Berhad [Company No. 200001008645(511251- V)] ("BOCM") and MSIG Insurance (Malaysia) Bhd [Company No. 197901002705 (46983-W)] ("MSIG") are jointly organising the eINSURED Protect ONg-LINE Promotion ("Promotion") commencing on 1 January 2025 and ending on 30 June 2025, both dates inclusive ("Promotion Period"), unless otherwise notified.

#### **TERMS AND CONDITIONS**

The following sets out the terms and conditions applicable to the Promotion ("T&Cs"):

## **ELIGIBILITY**

- 1. This Promotion is open to all BOCM customers and staff including Malaysian and non-Malaysian individuals from age 18 and above ("Eligible Customers").
- 2. Eligible Customers who have committed or are suspected of committing any fraudulent or wrongful acts in relation to any products and/or any of the facilities granted by BOCM or have been declared bankrupt (pursuant to a petition by either BOCM, other banks or by any third party) or are subject to any bankruptcy proceedings at any time prior to or during the Promotion Period shall **NOT** be eligible to participate in the Promotion.
- 3. For the purpose of this Promotion, the eligible insurance products offered by MSIG ("Eligible Insurance Products") are as follows:
  - (a) Private Car Insurance (i.e. Comprehensive Private Car / Motor Plus / Lady Motor Plus);

## **PROMOTION MECHANICS**

- 4. Eligible Customers must apply for and purchase the Eligible Insurance Products via BOCM's online network (i.e. BOCM's Mobile Banking App, Website (<a href="www.bankofchina.com.my">www.bankofchina.com.my</a>) and official social media such as Facebook and WeChat) during the Promotion Period. The application via BOCM's online network will then be routed and completed through MSIG's website at <a href="https://takeiteasy.msig.com.my/boc/">https://takeiteasy.msig.com.my/boc/</a>
- 5. Eligible Customers who have successfully signed up for any of the Eligible Insurance Products in the manner as provided in Clause 4 above and whose Eligible Insurance Products have been approved by MSIG with payment of insurance premium accepted by MSIG during the Promotion Period will be entitled to the following rebate ("**Rebate**"):

- 6. Eligible Customers are entitled for the Rebate (excluding service tax and stamp duty) upon completion of the purchase of the Eligible Insurance Product on MSIG's website and the Rebate will be immediately applicable on the final purchase price of the Eligible Insurance Product.
- 7. The Rebate given are non-transferable, non-exchangeable, and non-redeemable for cash, in part or in full and are subject to the T&Cs stated herein. No request for change of Rebate, or any parts, or appearances or accessories, or replacement or appeal will be entertained.
- 8. # Eligibility for Touch 'n Go (TNG) Reload PIN

- Eligible Customers will receive the TNG Reload PIN together with the e-Insurance Certificate and e-Policy Wording for each Successful Sign Up via email based on the email address which they have provided to MSIG during the sign-up process.
- 10. Eligible Customers are responsible for providing accurate and full contact details such as email address and contact number as required during the sign-up process to MSIG. Both BOCM and MSIG shall not be held responsible if MSIG is unable to contact the Eligible Customers based on the contact details provided by the Eligible Customers during the sign-up process.
- 11. In the event the Eligible Customers do not receive the TNG Reload PIN due to inaccurate contact information provided or the Eligible Customers are not contactable, MSIG reserves the right to forfeit the TNG Reload PIN and MSIG's decision is final and conclusive, and no correspondence will be entertained.
- 12. TNG Reload PIN is only valid for redemption through TNG's e-wallet mobile application ("**TNG App**"). The TNG Reload PIN is valid before the expiry date as stated in the TNG Reload PIN. The use of the TNG Reload PIN will also be subject to such terms and conditions imposed by TNG Digital Sdn Bhd [Company No. 201701042478 (1256651-M)] ("**TNGD**"). The TNG Reload PIN is not exchangeable for cash and is non-refundable.





BOCM and/or MSIG make no representation or warranty in respect to the suitability or validity of the TNG Reload PIN and services provided by TNGD and any complaints or disputes concerning the TNG Reload PIN under this Promotion shall be settled between the Eligible Customers and TNGD without any recourse to BOCM and/or MSIG.

- 13. All applications for any of the Eligible Insurance Products shall be subject to MSIG's approval and terms and conditions as may be imposed by MSIG at MSIG's discretion.
- 14. The insurance premium paid for any Successful Sign Up of the Eligible Insurance Products under this Promotion is **not refundable and not exchangeable** for up-front cash, credit, and cheque or benefit-in-kind.

The Eligible Customers are liable and shall personally bear all applicable taxes, government fees or any other charges that may be levied against them under the applicable laws, if any, in relation to their participation in the Promotion.

  - (c) agree to access BOCM's Website (<a href="www.bankofchina.com.my">www.bankofchina.com.my</a>) and MSIG's website at regular time intervals to view the T&Cs and to ensure to be kept up-to-date on any changes or variations to the T&Cs and/or details of the Eligible Insurance Products;
  - (d) agree that BOCM's and/or MSIG's decision on all matters relating to the Promotion shall be final, conclusive and binding on all Eligible Customers;

The T&Cs herein, and the terms and conditions of the Eligible Insurance Products shall be read together as an entire agreement and if there is any discrepancy between these T&Cs and the terms and conditions of the Eligible Insurance Products, the specific T&Cs herein shall prevail to the extent of such discrepancy.
- 18. In the event of any discrepancies between these T&Cs as compared to the advertising, promotional, publicity and other materials relating to or in connection with this Promotion, the final terms and conditions on MSIG's website shall prevail.
